# **Forsyth Barr New Zealand Equities Fund** Forsyth Barr Investment Funds Fund Update as at 30 September 2016



This fund update was first made publicly available on 4 November 2016. It is a replacement fund update for the update made publicly available on 31 October 2016. The only change is to provide the correct percentage value for the fund's top 10 investments.

## What is the purpose of this update?

This document tells you how the Forsyth Barr New Zealand Equities Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Forsyth Barr Investment Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

The Forsyth Barr New Zealand Equities Fund invests in New Zealand shares. We aim for positive long-term returns. These kinds of investments will typically have moderate to high levels of movement up and down in value.

## What are the risks of investing?

#### Annual return graph




#### Example of how this applies to an investor

Jane had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jane received a return after fund charges were deducted of \$2,717 (that's 27.17% of her initial \$10,000). This gives Jane a total return after tax of \$2,717 for the year.
