What is the purpose of this update?

Description of this fund

The Forsyth Barr NZ Fixed Interest Fund invests in selected New Zealand fixed interest assets. We aim for positive longterm returns. These kinds of investments will typically have low levels of movement up and down in value.

What are the risks of investing?

Annual return graph




Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor Jane had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jane received a return after fund charges were deducted but before tax of \$531 (that is 5.31% of her initial \$10,000). This gives Jane a total return after tax of \$382 for the year.
