What is the purpose of this update?

Description of this fund

What are the risks of investing?




Example of how this applies to an investor

Jane had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jane received a return after fund charges were deducted but before tax of \$15 (that is 0.15% of her initial \$10,000). This gives Jane a total loss after tax of \$91 for the year.

The top 10 investments make up 59.48% of the fund.

We actively manage the fund's foreign currency exposures. As at 30 June 2019, these exposures represented 95.04% of the value of the fund; the remainder of the fund was held as New Zealand dollar cash and cash equivalents. After allowing for foreign currency hedges in place, 77.81% of the value of the fund was unhedged and exposed to foreign currency risk.
