What is the purpose of this update?

What are the risks of investing?

Annual return graph




Example of how this applies to an investor

Jane had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jane received a return after fund charges were deducted but before tax of \$1,179 (that is 11.79% of her initial \$10,000). This gives Jane a total return after tax of \$1,073 for the year.
