Forsyth Barr KiwiSaver Scheme Personal Choice - NZ Fixed Interest Fund

What is the purpose of this statement?

This statement provides key information about the Forsyth Barr KiwiSaver Scheme Personal Choice - NZ Fixed Interest Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The general objective of the fund is to provide a gross return above the ANZ Corporate Investment Grade Bond Index return, on a rolling 12 month basis. We aim to achieve this by investing in a diversified portfolio of authorised investments, which may include New Zealand Government bonds, New Zealand dollar denominated debt securities of overseas Governments and international institutions, local authority debt securities, corporate debt and other securities, and cash. The fund is actively managed.



How has the fund performed in the past?


Members were also charged membership fees 3 of \$36 over the year to 31/03/14.

Members may also be charged fees for specific actions or decisions (e.g. members may make switches twice a year at no cost. Any subsequent switches will incur a \$25 fee). See page 16 of the current <u>Investment Statement</u> for more information about these fees.

Example of how this applies to a member Jane had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jane received a return after fund fees and tax were deducted of \$511 (that's 5.11% of her initial \$10,000). Jane also paid \$36 in membership fees. This gives Jane a total return of \$475 for the year.
