What is the purpose of this statement?

This statement provides key information about the Forsyth Barr KiwiSaver Scheme Personal Choice - Premium Yield Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The fund aims to provide a gross return 1.5% above the ANZ 90 Day Bank Bill index on a rolling 12 month basis. The fund can invest in a diversified portfolio of domestic and global fixed interest securities.




Members were also charged membership fees 3 of \$36 over the year to 31/03/14.

Example of how this applies to a member Jane had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jane received a return after fund fees and tax were deducted of \$271 (that's 2.71% of her initial \$10,000). Jane also paid \$36 in membership fees. This gives Jane a total return of \$235 for the year.
