Forsyth Barr KiwiSaver Scheme Personal Choice - Premium Yield Fund





What is the purpose of this statement?

This statement provides key information about the Forsyth Barr KiwiSaver Scheme Personal Choice - Premium Yield Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The fund aims to provide a gross return 1.5% above the ANZ 90 Day Bank Bill index on a rolling 12 month basis. The fund can invest in a diversified portfolio of domestic and global fixed interest securities.



How has the fund performed in the past?

What fees were members charged?

Members were also charged membership fees⁴ of \$30 over the year to 31/03/13.



Example of how this applies to a member

Jane had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jane received a return after fund fees and tax were deducted of \$170 (that's 1.70% of her initial \$10,000). Jane also paid \$30 in membership fees. This gives Jane a total return of \$140 for the year.

- ² Fund fees are fees charged as a percentage of a member's interest in the fund (i.e. as a percentage of their KiwiSaver account balance).
- ³ A change in the fee structure from 1 April 2013 resulted in an increase in the management fee to 1.0% and scheme expenses to 0.2% (these are included in "other fees and costs"). However, total fund fees reduced due to full rebating of the underlying fund management fee (also shown as part of "Other fees and costs"). The calculation and sample provided here assumes 100% has been invested in this fund.
- 4 Membership fees are the fixed dollar charges for membership in the KiwiSaver scheme. From 1 April 2013, individual membership fees increased from \$30 to \$36 per year.
- ⁵ Kevin Stirrat and Craig Alexander are employees of Forsyth Barr Limited (and not the manager). The manager has delegated part of the day to day management of the scheme to Forsyth Barr Limited.
