What is the purpose of this statement?

The general objective of the fund is to achieve positive longterm returns by investing in selected Australian equities, subject to the higher risks associated with investments in international equity markets. The fund is actively managed.




Members were also charged membership fees 3 of 36 over the year to 31/03/14.

Example of how this applies to a member Jane had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jane received a return after fund fees and tax were deducted of \$92 (that's 0.92% of her initial \$10,000). Jane also paid \$36 in membership fees. This gives Jane a total return of \$56 for the year.
