#### What is the purpose of this statement?

This statement provides key information about the Forsyth Barr KiwiSaver Scheme Personal Choice - New Zealand Equities Sector. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

#### Description of the fund

The general objective of the fund is to achieve positive longterm returns by investing in selected New Zealand equities, subject to the higher risks associated with investments in equity markets. The fund is actively managed.



#### How has the fund performed in the past?2


#### Example of how this applies to a member

Jane had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jane received a return after fund fees and tax were deducted of \$1,379 (that's 13.79% of her initial \$10,000). Jane also paid \$36 in membership fees. This gives Jane a total return of \$1,343 for the year.
