# What is the purpose of this statement?

This statement provides key information about the Forsyth Barr KiwiSaver Scheme Personal Choice – Listed Property Sector. # Description of the fund

The general objective of the fund is to achieve positive long-term returns by investing in selected New Zealand and Australian listed property vehicles, subject to the higher risks associated with investments in listed property investments. The fund is actively managed.




# Example of how this applies to a member

Jane had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jane received a return after fund fees and tax were deducted of \$1,498 (that's 14.98% of her initial \$10,000). Jane also paid \$36 in membership fees. This gives Jane a total return of \$1,462 for the year.
