What is the purpose of this statement?




Example of how this applies to a member

Jane had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jane received a return after fund fees and tax were deducted of \$1,516 (that's 15.16% of her initial \$10,000). Jane also paid \$36 in membership fees. This gives Jane a total return of \$1,480 for the year.
